### **Noteworthy Newsbites**

October 17, 2012 Update from NMLB on VS restrictions: The New Mexico Livestock Board is relaxing the movement and health care restrictions on all counties in NM except Los Alamos, San Miguel, and Taos counties where there are ongoing investigations and quarantines. Movement restrictions and 5 day CVI for events in these counties or livestock traveling out of these counties will remain in effect. Persons with livestock traveling out of state from Los Alamos, San Miguel, and Taos counties must obtain permission from state of destination prior to movement. Canada and other states may continue restrictions on NM livestock movement for an indefinite period of time. All NM producers and veterinarians must contact state of destination prior to movement.
